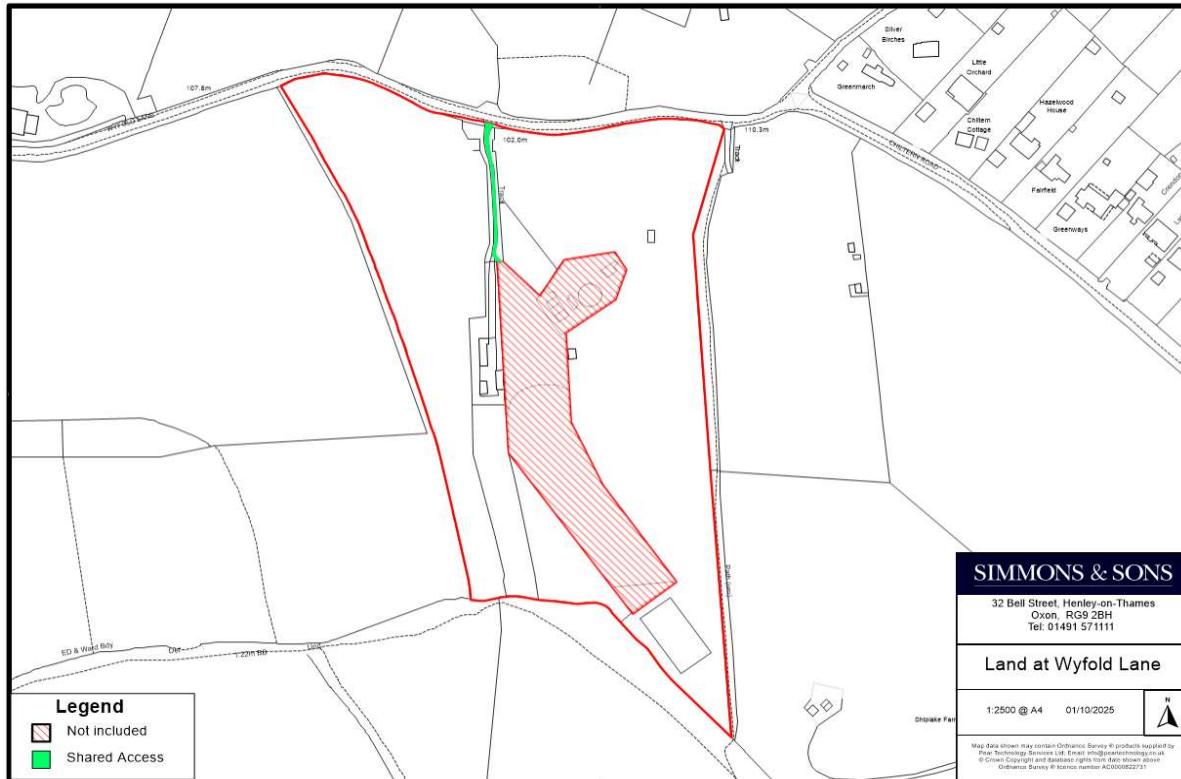

A rare opportunity to purchase a comprehensive Stable Yard with 3 loose boxes, tack room, manège, 2 mobile field shelters (with 5 further loose boxes) and approximately 10.78 acres of pasture located on the outskirts of Peppard Common.

SITUATION

The land is located to the west of Peppard Common, approximately 3 miles to the west of Henley-on-Thames and 4.5 miles north of Reading. The land lies within the Chilterns National Landscape. A location plan may be found at the end of these sales particulars.





SERVICES

The land is sold subject to and with the benefit of all rights including rights of way, whether public or private, light, support, drainage, water and electricity supplied and other existing and proposed wayleaves from masts, pylons, stays, cables, drains, water and gas and other pipes whether referred to in these particulars or not.

The land benefits from mains water only and is crossed by a line of timber utility poles. Interested parties are advised to undertake their own enquiries regarding services connection and other utilities.

ACCESS

Access to the Property is gained via a set of metal field gates off Wyfold Lane. The owners of the land in the centre of the holding (hatched red on the plan) have a right of access over the track tinted green on the plan.

PLANNING

The Title Register contains restrictive covenants including a modern covenant from 2007 prohibiting the erection of any structure on the land save for the stabling of horses or shelter of horses.

Interested parties are advised to make their own enquiries in respect of planning matters.

From Henley-on-Thames go west on Greys Road and south on the B481 through Rotherfield Peppard, into Peppard Common, then north on Chiltern Road and west onto Wyfold Lane.
