DESCRIPTION

An opportunity to acquire a relatively level block of agricultural land with good road frontage and easy access to the A24. Situated in a secluded rural location and surrounded by a mixture of woodland and farmland. The land is offered for sale as a whole.

Local: The village of Capel with parish church, public house and village stores lies about 1.2 miles north west. Rusper approximately 5.6 miles to the south.

Towns: 8.9 miles north of Horsham and 6.7 miles south of Dorking.

Transport: Gatwick Airport 10.7 miles. Horsham train station 8.2 miles. Warnham train station is about 7.4 miles. A24 to London, Gatwick Airport and the national motorway network.

DIRECTIONS

From Capel Village, which lies just off the A24, turn east opposite the church by the garage into Vicarage Lane. Follow the lane to the point where the road bears sharp left and turn right into Temple Lane. Continue for approximately 0.7 miles. The entrance to the land will be found on the right hand side.
