SITUATION

The land is located to the west of Whittlesey Road, Benwick, March, Cambridgeshire. The land is accessed over a right of way along a track leading from Whittlesey Road.

DESCRIPTION

The land extends in total to 38.11 acres (15.42 hectares) (more or less). The fields are numbered TL3291 - 4572, TL3291 - 4352 and Part TL3291 - 4134 on the Rural Land Register. It is registered with Land Registry under Part of Title Number CB140351 and Part of Title Number CB425405.

NOTE: The Vendor is retaining a strip of land adjacent to the shed in field TL3291-4134 as shown for identification on the plan. The purchaser of the land may be able to farm this strip by arrangement. The Vendor is also retaining the yard area in the south western corner of this field. Boundaries will be staked on site in due course.

POSSESSION

Vacant possession will be given upon completion of the purchase, subject to holdover in respect of growing crops, if necessary.

LAND AND SOIL CLASSIFICATION

The land is classified as Grade I on the Agricultural Land Classification Map of England and Wales. The land is of the Downholland 1 Series described as marine alluvium and fen peat suitable for a wide range of cropping including Sugar Beet and Potatoes.

SERVICES

There are no services connected to the land.

BASIC PAYMENT SCHEME

The land is registered with the Rural Payments Agency and claims have been submitted. All delinked payments belong to the Vendor.

SPORTING AND MINERAL RIGHTS

These are included in the sale, as far as they are owned.

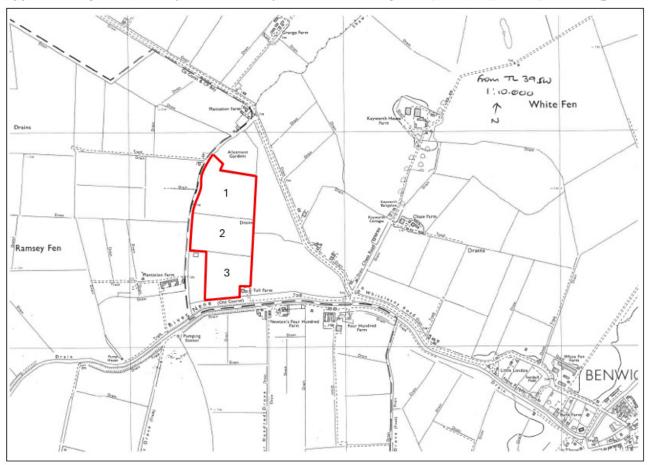
